Ezdan Holding Group (ERES)

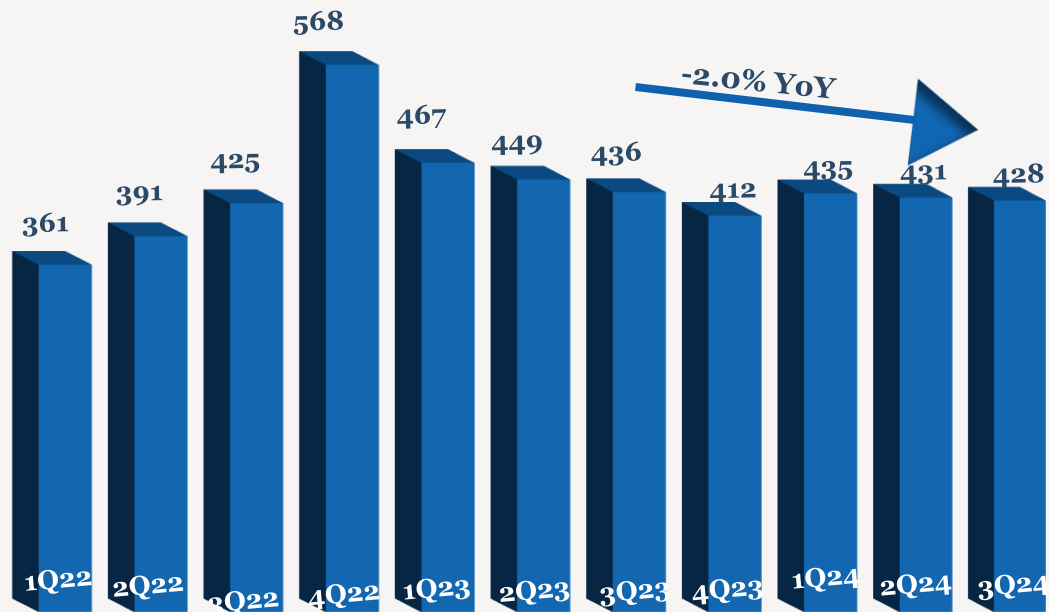
- > Net profit decreased by 52.6% YoY to QR28mn (-65.9% QoQ) in 3Q2024 primarily due to lower other income and lower rental income. For 9M2024, net profit was down 7.1% YoY to QR204mn.
- > Net operating profit decreased by 2.2% YoY to QR356mn (-3.8% QoQ) in 3Q2024. For 9M2024, net operating profit was down 3.6% YoY to QR1,101mn.
- > Total revenue decreased by 2.7% YoY (-1.2% QoQ) to QR446mn in 3Q2024 due to lower rental income. For 9M2024, total revenue was down 4.5% YoY to QR1,357mn.
- > For 3Q2024, EPS came at QR0.001 vs. QR0.002 in 3Q2023. For 9M2024, EPS was flat at QR0.008.
- > As of 26th October 2024, the stock increased 11.8% YTD, Outperforming the QSE Index, which was down by 4.0% YTD.

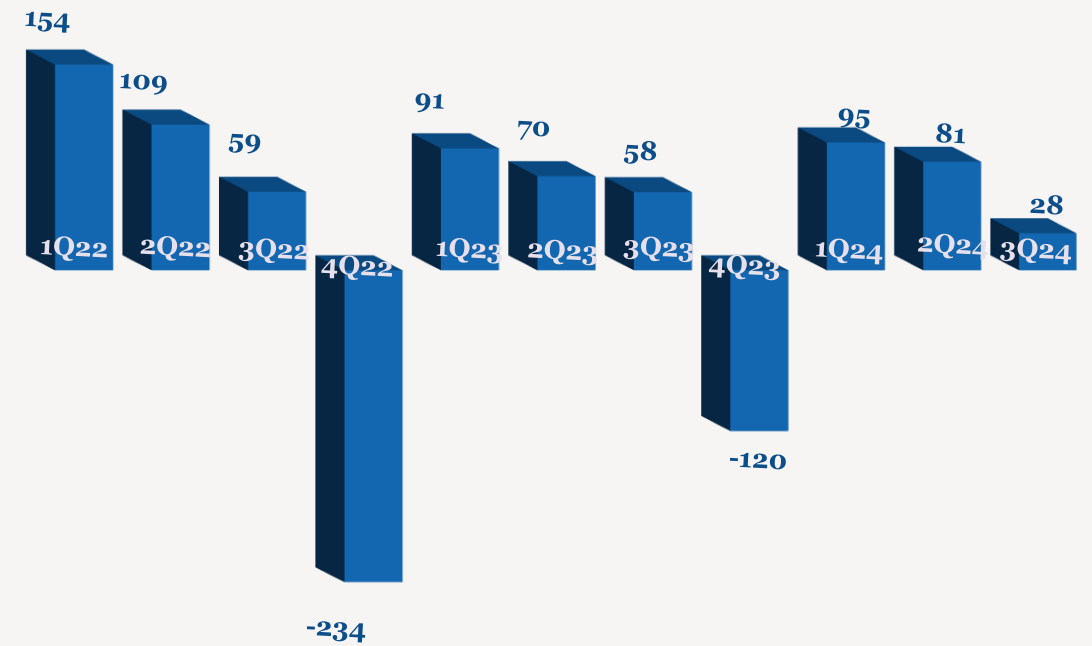

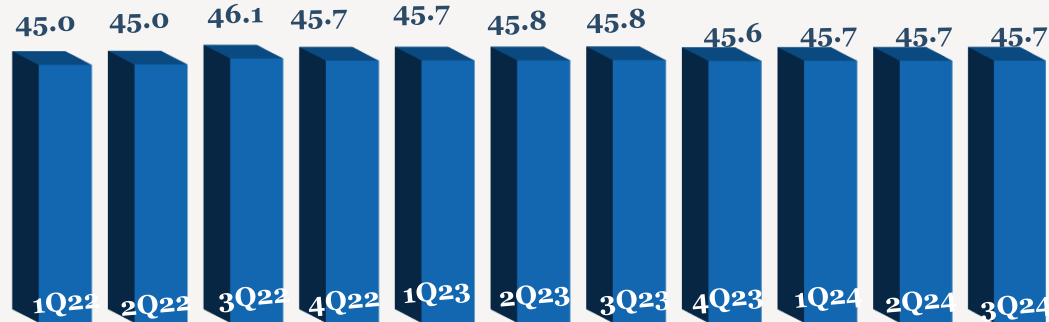
Quarterly Rental Income Trend (QRmn)



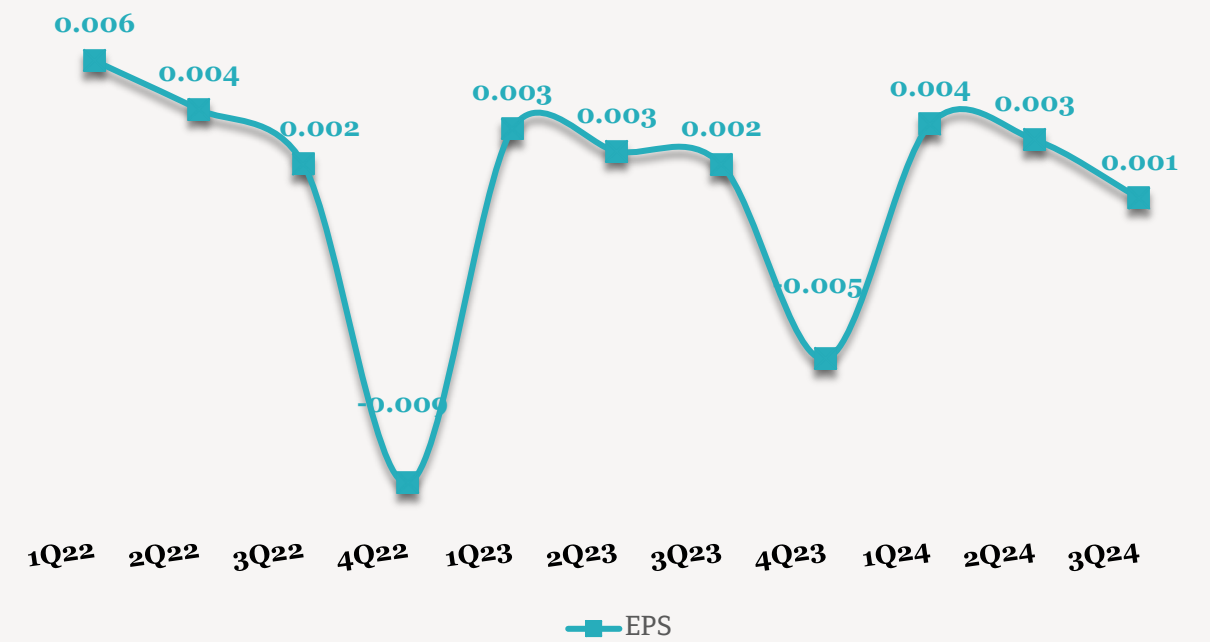
Quarterly Earnings Trend (QRmn)
