

Mesaieed Petrochemical Holding Company (MPHC)

- > Net profit decreased by 27.8% YoY to QR194mn (-17.0% QoQ) in 1Q2024 owing to a lower share of results from joint ventures.
- > The share of results from joint ventures fell by 35.7% YoY to QR156mn (- 18.4% QoQ) in 1Q2024.
- > For 1Q2024, EPS came at QR0.015 vs. QR0.021 in 1Q2023.
- > **As of 2nd May 2024, the stock has increased 1.7% YTD, outperforming** the QSE index, which was down by 11.3% YTD.

> The stock is currently trading at TTM P/E multiple of 22.7x, higher than its 1Y historical average of 18.4x.






Quarterly Share of Results from Joint Ventures Trend (QRmn)




Investment in Joint Ventures (QRbn)
