

Qatar Islamic Insurance Group (QISI)

- > Net profit grew by 46.8% YoY to QR43mn (+8.8% QoQ) in 1Q2024 primarily due to an increase in gross written premium and increase in net claims incurred.
- > Gross written premium rose by 28.9% YoY to QR190mn (+75.4% QoQ) in 1Q2024.
- > Net earned premium (NEP) of QR129mn came higher by 54.1% YoY (+62.7% QoQ) in 1Q2024.
- > Loss ratio increased by 5.8ppts to 41.2% YoY (-28.6ppts QoQ)


- > For 1Q2024, EPS came to QR0.29 vs. QR0.20 in 1Q2023.
- > As of 1st May 2024, the stock has decreased 4.5% YTD, outperforming the QSE index, which was down by 10.4% YTD.




Quarterly Gross Written Premium Trend (QRmn)
